

Abort the Supreme Court?

In front of Rockland's Courthouse last week a group of demonstrators were holding up signs, one of which particularly caught my attention: "Abort the Supreme Court." I walked over and talked with the demonstrators - a civil conversation. My philosophy is that government should not interfere in such private matters as abortion, so we agreed on that, but as someone trained in the law, and as someone who highly values the rule of law, I found it disturbing that abortion rights advocates would go so far as to advocate the abolition of the Supreme Court.

From our conversation it became clear that they had not thought this through, but I remain concerned that our extreme political polarization is encouraging thoughtless extremism, and growing disfunction in our democracy.

The decision of the Supreme Court overturning the 50 year precedent of Roe v. Wade was not a decision that abortion is wrong and should be punished, it was a decision that abortion is not a right protected by the Constitution. This decision reflected a more conservative approach to Constitutional interpretation than was the approach of the majority which decided Roe v Wade in 1973.

Where the balance should be between strict and liberal construction of the Constitution is an important question, but what must decide this is not popular opinion, but the opinion of the majority of the Supreme Court,. It is also important to understand that the overturning of a 50 year precedent is not in itself a necessarily bad thing. We might remind ourselves of the 1954 decision in Brown v Board of Education which overturned the 1896 holding of Plessy v. Ferguson allowing "separate but equal" education of whites and blacks.

Also important to understand is that the decision overturning Roe is not requiring legislatures to ban abortion, it is simply allowing them to make such laws concerning abortion as they deem appropriate. Here in Maine it is unlikely that our legislature is going to ban abortion - that would be very unpopular with their electorate.

In those states where there is popular support for banning abortions, they are likely to find that such bans will be of somewhat limited effect because states cannot criminalize conduct in another state. People will travel to another state to get an abortion - an significant inconvenience for sure, but hardly existential.

What is existential is the degree of hysteria and partisan hatred to which our polarization has led us. Perhaps on this path we will truly abort the Supreme Court, and our Constitution, and enter on the path to the sort of authoritarianism which overtook failed democracies in Europe in the nineteen twenties and thirties..

Meanwhile, not to be too fatalistic, or too serious, there is a great irony afoot. The overturning of Roe has given a huge political boost to the Democrats, the party that advocates abortion rights. The Democrats' formerly bleak prospects for November have suddenly been greatly improved. Indeed Donald Trump, our idiot savant scheister-in-chief, a former Democrat who once supported abortion rights, has, according to the New York Times, privately told friends and advisers that the ruling will be "bad for Republicans."

I suspect he is right. Courier-Gazette reporter Steve Betts recently wrote an article in which he asked local legislative candidates for their reaction to the overturning of Roe. All the Democrats responded enthusiastically condemning it. Two of the six Republican candidates gave ambiguous responses, the other four Republicans declined to respond.

And this brings up another point. In a sense the Supreme Court has just aborted itself. It has concluded that the question of whether abortion should be allowed, and under what circumstances, is for the legislative branch to decide, which is to say it is a question for the people, not the courts. It is now up to all of us to contribute thoughtfully and constructively to that decision.

This morning's mid-coast fog brought the scent of the nearby ocean. There isn't a perfumer in the world that can match it. I cannot even describe the aroma, except the feelings evoked of spending time oceanside over the decades: Salty, sweaty skin after sunbathing; sandy feet with the grit between my toes; the beach chair that sinks into the sand; molding sand castles that wash away with the tide; plastic buckets and shovels of childhood; eating lunch time sandwiches under an umbrella;

Beach sand in my bathing suit and bed sheets; body surfing; beachcombing for anything interesting; avoiding jellyfish; the red sun going down and time to leave.

After 50 years, the ultra conservative SCOTUS majority killed American women's legal, constitutional right to choose an abortion. Conservative states promptly enacted their "trigger laws" and other legislation to limit or outright ban abortions. If Clarence Thomas has his way, SCOTUS will go after abortion pills, contraception, gay rights and who knows what other Americans' rights established by stare decisis, i.e. legal precedence. Sen. Susan Collins is now whining that Kavanaugh and Gorsuch promised her they wouldn't overturn any legal precedents. Collins is too naïve to serve the people of Maine, especially Maine women.

Whether it is domestic violence perpetrators, or legislators, or a former president, or SCOTUS, conservative men in power want to control women and their bodies.
